

Project update

About the project

The SEC Renewable Energy Park – Horsham is Victoria's first 100 per cent publicly owned largescale renewable energy project.

The SEC is working with developer OX2 to build the energy park which includes a 119-megawatt solar farm comprising more than 212,000 PV solar panels. This will generate around 242,000 megawatt hours (MWh) of renewable energy a year, enough to power 51,000 homes, along with a 100MW two-hour battery energy storage system (BESS).

Project activities

Preconstruction works at site began in February 2025 and are ongoing. Activities underway include weed management, establishing a 'laydown' or temporary storage area, erecting a fence around the site, constructing access tracks and the delivery of materials for the solar farm.

From the end of March, we began installing support structures for the solar panels. This involves piling works and the installation of torque tubes which support the solar panels. These tubes allow the panels to tilt east to west to get the best sunlight.

Installing the solar panels will begin following completion of these works.

Over the coming months, works will continue in accordance with planning approvals, including completing the laydown area and access tracks and roads.

We'll keep you updated as the project progresses.



How we're managing fire risk

Safety is our number one priority, and we will be adhering to strict fire management conditions throughout the project. A detailed Fire and Emergency Management Plan was developed in consultation with the CFA and we are committed to working with the local fire brigade on fire management.

This includes working with the local CFA and inviting them to the site to build their familiarity with the project, discuss training and find opportunities to support the local brigades. This will continue as the project progresses.

We're managing fire risk currently in the following ways:

- · Only having diesel vehicles onsite.
- · All vehicles must have a fire extinguisher.
- All temporary buildings must have a fire extinguisher outside.
- Weed management with the guidance of an agronomist.
- A requirement for a hot works permit for any activities governed by fire risk and total fire ban days.
- Two water carts on-site. One cart carries 10,000 litres of water and has a water cannon attached.
 The second water cart carries 20,000 litres of water.
- Regular meetings with the Horsham and Green Lake CFA.



How we're managing dust

We are working hard to minimise the impact of dust during the project's construction. Spraying water is the most effective way to do this and water trucks are being used to wet down work areas and unsealed roads as needed.

Our dust mitigation is in line with the Environmental Management Plan which was developed as part of planning permit approvals for the project.

Job opportunities

Enhancing local employment and supplier opportunities is one of our key goals.

The SEC, OX2 and our delivery partners will continue to closely engage with the local community and businesses to maximise opportunities for local businesses and employment where possible.
